 - HS season, swimmers at SP given 25% discount.

- Based on this and the 12 week high school season considering a 12.5% discount for the junior high swimmers.
- SP middle school swimmers in Gold 2, 5 weeks they were swimming with middle school
- Couldn't attend all practices
- General discussion re. refunding \$125 or offering a credit of this amount.
- Considering refunding half of the 25% refund offered to high school for the junior high swimmers. This would be 12.5% refunded to 3 swimmers. For swimmers participating during the Sept. - Nov. time.
- Question had been raised from some parents of junior high swimmers.
 - A 12.5% discount is \$89. Taryn working with Dana on an email to these families regarding this refund.
